Notice of piling works on the former National Temperance Hospital site

October 2020

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) guidance on COVID-19. The Government's strategy makes it clear construction can continue as long as it complies with this guidance. All sites remain under constant review. Piling works – October 2020 – January 2021

From 26 October we will start constructing the western basement wall of HS2 Euston Station. This is called a retaining wall, which is built with large concrete columns (piles) that are placed in the ground.

We will do this by using a piling rig with a rotary bore. This will make a hole in the ground, where a steel cage will be placed and filled with concrete.

Due to the nature of the work you may experience periods of noisy site activity and there will be increased lorry movements accessing the site. We anticipate an average of 20 vehicles per day. Lorries will be entering and exiting the site at Hampstead Road.

To manage noise and disruption we will raise the height of the hoarding barriers along Cobourg Street from 2.4m to 3.6m and closely monitor all noise, vibration and dust levels to ensure we do not exceed our agreed limits.
